## General dates and policies for the East Coast Conference:

The following information relates to any attendee, sponsor, or guest speaker (collectively "Participant(s)"):

- Early Bird Attendee Registration deadline is March 1, 2024.
- Individual attendee registrations made online and paid by credit card will be accepted until March 25, 2024 at 11:59 p.m., unless sold out earlier.
